B. Principal's Report

Highlights from our first week back: we didn't flood!, students are happy to be back and having fun seeing friends again. We were well prepared fro any contingency caused by recent weather. ELAC meeting met for the first tine yesterday (led by Julie), they are excited to do a cinco de mayo fundraiser.

Hearing screening coordinated and donated by nurse/parent) took place this week, went well Welcoming schools training continued last week with the goal of continuing to build capacity throughout campus on micro-aggressions, inclusion, equity. Thanks to parent volunteers all staff were able to attend.

Food program and kitchen logistics are going well. Thank you Melissa and the kitchen team who continue to improve.

PBL theme this trimester is adaptations: teachers are working with Maia Steward and Emily Selim to incorporate more science into the PBL projects and this is a good fit.

Spirit week is next week, literacy week is in the works and principal and CSD are meeting daily (in her first week) and will continue partnering to move our goals forward.
